Likewise, the Company may also hold interests as partner or shareholder in other public service companies either directly or through partnerships with other persons. Furthermore, it will be able to develop and participate, either directly or indirectly, in engineering and infrastructure projects and make investments in this field, including the provision of services and activities related thereto.</p> <p>In furtherance of its corporate purpose, Empresa de Energía de Bogotá S.A ESP may undertake any other activities inherent in and complementary to its main corporate purpose, including, particularly, the following:</p> <ol style="list-style-type: none"> <li>1.
